Instructions for using the self-assessment grid

The self-assessment grid is based on the six level scale of the common European framework of reference for languages (CEF) developed by the Council of Europe.

The grid consists of three broad levels as follows:

- Basic user (levels A1 and A2);
- Independent user (levels B1 and B2);
- Proficient user (levels C1 and C2).

To self-assess your foreign language level, read the descriptions below and write the relevant level (e.g. C2 - Proficient user) in the adequate box of table above (Listening, Reading, Spoken interaction, Spoken production and Writing).
